Release, Authorization and Permission for a Minor to Self-Check In/Out

For the safety of your child, we must have on file a written release/authorization/permission form (hereinafter "permission form") from the parent/legal guardian, permitting your child to arrive and/or depart from the program without parental sign in/out. Self-check in/out is allowed with parental consent for minor participants age 14 or older and in grades 9-12 in programs allowing self-check-in/out.

In addition to this form, a Participation Agreement and Release is required for the minor to participate in the program.

- SELF SIGN IN:** Participants will sign themselves into the program daily (when applicable). If the participant arrives 15 or more minutes after the start time of the program, the parent/guardian listed on this form will be contacted. Excessive or consistent lateness may result in dismissal from the program at Vanderbilt.
- SELF SIGN OUT:** Participants will only be released at the scheduled program ending time, or at another time authorized to the program in writing by the parent/legal guardian. If the Participant identified above does not have a fully executed permission form on file, Participant will not be released without authorized adult supervision. You will be called to pick him/her up from at the end of the program.

AGREEMENT

By signing this permission form, I authorize my child listed above to arrive and/or depart at the scheduled start/end time of the Program identified above unsupervised. This includes, but is not limited to, permission to drive (if personal vehicles are permitted in the program), walk, use of public transportation, walk home from the participant's regularly scheduled bus stop and waiting at the bus stop unsupervised. I understand the risk associated with the foregoing, including but not limited to property damage and personal injury, and agree that Vanderbilt University (hereinafter "Vanderbilt") accepts no responsibility for my child's acts or the acts of others that are in anyway associated with my child being allowed to self-check-in and/or out. I hereby release and hold Vanderbilt, its trustees, employees, agents, volunteers, and/or assigns, harmless from any and all liability and from any and all claims, demands, losses, expenses, actions or causes of action which arise out of or occur during or as a consequence of or in connection with participation in the Program, including but not limited to my child's self-check- in/out from the Program, except such liability or claim of liability as may result from gross negligence on the part of Vanderbilt. I affirm my understanding that Vanderbilt is not responsible for the participant prior to check-in and after check-out from the program.

This form is not to be used to designate carpools for adult pick up of participating minors.
