- 5. Copies of all letters of appointment or other communications informing individuals enrolled as graduate students at Vanderbilt University that they are to receive payment from Vanderbilt University, including all conditions and requirements for the receipt of such payments.
- 6. All records, including but not limited to payroll records, benefit plan summaries, summary plan descriptions, and benefit administration records for the 2022- 2023, 2023 2024, and 2024 2025 academic years, showing in regard to all petitioned-for-employees their names, job classifications, job codes, departments, rates of compensation, including fellowship payments and other financial aid, dates of hire, weekly hours worked, and benefits received.
