- Identify important factors to include in policy brief on achieving UHC




Figure 1. The 5 leading topics of concern to UHC2030 stakeholders

### **OUTCOMES AND EVALUATION**

This practicum was successful in gaining more knowledge and understanding of UHC. This was addressed through an assessment of the add value of UHC multistakeholders through a review of the current UHC literature and stakeholder statements, creation of metrics and spreadsheets, along with the development the case study for the policy briefs.

An important lesson learned was recognizing that achieving UHC requires great effort from many stakeholders, especially the community itself who are crucial in this initiative and will help create a sustainable program.

ADVOCACY	Facilitating awareness and sensitization (health promotion, right to health, etc.)     Facilitating networking between different people of the community     Facilitating social movement (walk, exhibition, action learning forums)     Capturing successful experiences
PARTICIPATION IN DECISION- MAKING PROCESS	Bringing holistic community perspective of health issues in the specific context Supporting to national bodies to review or formulate policies, guidelines and procedures Identifying needs, gaps and formulating practical recommendations, solidarity messages, practical solutions and actions Participating in policy dialogue Facilitating stakeholders' coordination Inclusion of marginalized and vulnerable groups (including gender issue and community health management committee)
PARTICIPATION IN IMPLEMENTATION OF INTERVENTIONS	Providing direct health services to effected community Bringing language and cultural consideration Mobilizing resources to address the health issues Providing capacity building support to community Supporting effective decentralization of health services and interventions (including financing mechanism)

Ongoing challenges include understanding stakeholders' motivations that ultimately impact their support and the success in achieving UHC.
