

# Contractor's General Conditions Costs

August 15, 2025

## DEFINITIONS

- A. Overhead Percentage** includes all overhead costs incurred by the Contractor which are not specifically stated as Direct Reimbursable Costs in Section 16.6 of the Agreement. These items include, but are not limited to, the items indicated as "Overhead Percentage" in Table 1 below. This percentage shall be determined prior to the execution of the Agreement.
- B. Direct Reimbursable Costs** include only the items itemized in the Agreement and indicated as "Direct Reimbursable Costs" in Table 1 below. An itemized estimate of Direct Reimbursable Expenses shall be submitted by the Contractor prior to the execution of the Contract.
- C. Staffing Costs** are as defined in Section 16.4 of the Agreement and listed in Table 2 below.

## SUBMITTALS

- A. Overhead Percentage stated as a percentage of the Cost of the Work submitted prior to the execution of the Agreement.
- B. Itemized estimate of Direct Reimbursable Costs submitted prior to the execution of the Agreement.
- C. Documentation of the actual costs for each labor burden component shall be submitted within 30 days of the execution of the Agreement. Documentation shall consist of copies of invoices for insurance premiums, employee records showing vacation time accrued, and other direct evidence of payment or actual costs incurred.
