#### **RECRUITMENT TIMELINE**

The **finance industry recruits early**, with investment banks opening applications for junior year summer internships as early as January of sophomore year—18 months in advance. Recruiting for summer internships in other areas of finance typically begins in the spring of sophomore year as well, though there are still some roles posted closer to the start date. Since junior summer internships often lead to full-time offers, being prepared and proactive is essential.

Many finance firms offer Early Insights or Experiential Learning programs for first-year and sophomore students which provide the opportunity to explore a particular firm or a specific job role. Applications for these programs open in the summer or early fall and can help students stand out by demonstrating an interest in finance and establishing relationships with hiring contacts. **Read the weekly Vandy in Finance newsletter to explore recruiting resources** and secure your internship.
